The New Zealand Certificate in Financial Services (Level 5) (General Insurance) is the qualification for you if you need to meet the regulatory competency requirements for giving financial advice, or you want to advance to specialist roles and enhance your skills and knowledge within retail and personal services areas of the financial services industry. It is delivered by distance, so if you're already working in the industry you won't need to give up your job to get ahead in your career.

Qualification structure

This programme is made up of two general courses (FSC521 and FSC522) that are part of all strands. The third course that must be completed to achieve the qualification is the specialist course for your chosen strand.

You can do more than one strand if you choose.

To meet the competency requirements of Standard 8 of the Code of Professional Conduct for Financial Advice Services you must complete the strand that is most relevant to the type of product you advise on. Entry requirements

To enrol in this programme you need to have:

- a minimum of eight NCEA Level 2 credits in English, four in writing and four in reading, or
- be able to show equivalent knowledge or skills relevant to all those products.

20 Years old or over

If you are 20 years of age or over and do not hold the minimum entry requirements you will be eligible to be enrolled where your previous educational, work or life experience indicates you have a reasonable likelihood of success.

English language

International students must also have an IELTS (Academic) score of 5.5 with no band score lower than 5.0, or equivalent.

Domestic students for whom English or Māori is not their first language must also have an IELTS (Academic) score of 5.5 with no band score lower than 5.0, or equivalent.
